Joint Commission Releases Guidance on Surgical Attire, USP ...

Articles published in the AORN Journal by leaders of the organization described the need to eliminate access to surgical caps in the name of patient safety. 6-8 The most recent guidelines for surgical attire do not specifically mention the surgical cap but do describe head attire that covers all hair and the wearer’s ears, which, essentially, prohibits the use of the cap.

Guidelines in Practice: Surgical Attire - Link - 2020 ...

Surgical attire and personal protective equipment (PPE) are worn to provide a high level of cleanliness and hygiene within the perioperative environment and to promote patient and worker safety. Reducing the patient’s exposure to microorganisms that are shed from the skin and hair of perioperative personnel may reduce the patient’s risk for surgical site infection (SSI).

The Joint Commission standards do not prescribe operating room dress\surgical attire. To determine the appropriate requirements for a given organization, surveyors will review facility practices and policies to determine if they have followed the hierarchical approach to infection control standards that was published in the April 2019 edition of Perspectives(\*).

The Joint Commission standards do not require employers to launder surgical scrubs or other attire. However, The Joint Commission’s Leadership Standard LD.04.01.01 requires health care organizations to adhere to applicable federal (e.g. OSHA), state and local regulations (e.g., licensing requirements), and if deemed, Centers for Medicare and Medicaid Conditions of Participation and/or ...
